**BRING:** 

sleeping bags or bedding,

towels, cooking and eating utensils (microwave proof), videos, no TV reception, (the park will provide a list of local video rental places).

No one under 18 may rent a Yurt without an adult staying overnight. Maximum seven people per Yurt.

Maximum 2 vehicles per Yurt. (There is a \$5.00 fee for the second vehicle). There is no addititional parking available.

No smoking, tents, RV's, campers or camp trailers. Pets are strictly prohibited inside the yurt.

If you have problems with the combination, see camp host in site number 1.

Check out time is 1pm. Check in time is 4pm. You MAY NOT check in earlier.

This Yurt is fully ADA accessible.

Yurt is located only 100 feet from the parking lot.

Yurt includes a full bathroom with walk-in shower, two futon couches (which fold down to a double bed), a bunk bed (with a single on the top and a double on the bottom), dining room table and chairs, TV and VCR (no cable or reception), microwave, refrigerator/freezer, sink and outdoor propane barbeque.

Please note that while we make every effort to keep our facilities free of pests such as insects and spiders, these are outdoor facilities and are not sealed in a way that will prevent the re-entry of these pests once the facilities are cleaned.

Directions to Umpqua Lighthouse State Park
On Highway 101, 5 miles south of Reedsport, 17 miles north of North Bend
Bridge, on the west side of Hwy 101. Follow signs.

# Read this to make your trip go smoothly!

- Please be aware that only the person whose name is on the reservation may change or cancel a reservation.
- Your reservation includes one vehicle for individual overnight reservations. If you have an additional vehicle, and if the
  site allows additional vehicles, you must register and pay an additional \$5 per night / per vehicle fee when you arrive at
  the park.
- Some Oregon State Parks charge a day-use fee to visitors who are not camping. If you have a reservation in a day-use area and the park charges a day use fee, **all** attendees are required to pay this fee. The fee is \$3 per vehicle (12 and 24 Month Passes may be purchased from the park or the Oregon State Parks Information Center.)
- Some day use facilities require a cleanup/damage deposit. The deposit will be returned, as long as the area is left clean and undamaged.

#### Cancellations

- The reservation and transaction fees are non-refundable. No exceptions.
- Campsite, rustic yurt, rustic cabin, tepee, or boat moorage: If you cancel within 3 calendar days of your arrival date, OPRD retains your first night's use fee, reservation fee and transaction fee (if any).
- Deluxe yurts, deluxe cabins, all day-use buildings, shelters and areas, group camps, youth camps, ranches, or horse camps: If you cancel within one month to the day of your exact arrival date, OPRD will retain your first night/day use fee, reservation fee, and transaction fee (if any).
- If your arrival date is today or tomorrow **you must call the park where you have reserved**; the phone number is listed in the "Notes" section of your confirmation. If your arrival date is after tomorrow, please call Reservations Northwest: Portland Metro Area 503-731-3411 or outside Portland 800-452-5687. Cancellation requests can be made 24 hours a day, 7 days a week through the automated voicemail system or via email at OPRD.Reservation@state.or.us.

## Late Arrivals and No Shows for overnight reservations.

- If you have reserved multiple days and arrive at the park the day after your scheduled arrival date but before 1pm, your reservation will be honored; however, you will be responsible for the previous night's fee. If you do not check in at the park by 1pm the day after your scheduled arrival date your entire reservation(s) will be cancelled and all fees refunded except the first night's fee(s), reservation fee(s) and transaction fee(s) (if any). This includes customers paid in full and express check-in customers.
- If you have day use buildings, shelters, or areas reserved, please see the "Campground Policies" section on your confirmation for check in/out times, specific park information and policies. For more information, please call the Oregon State Parks Information Center at (800) 551-6949, Monday through Friday from 8am to 5pm, Pacific Time.

#### Changes to reservations

- There will be a \$6 non-refundable transaction fee for any changes made to a reservation.
- Changes can only be made by phone. Reservations Northwest year-round hours are, Monday-Friday, 8am to 5pm, Pacific Time, closed on State holidays.
- Campsite, rustic yurt, rustic cabin, tepee, or boat moorage: to make changes more than 3 calendar days before your stay (including your arrival date), call Reservations Northwest. Changes cannot be made within 3 calendar days of your scheduled arrival date.
- Deluxe yurts, deluxe cabins, horse camps, all day-use buildings, shelters, areas, group camps, youth camps, or ranches: to make changes call Reservations Northwest at least one month before the exact date of arrival. If it is less than one month prior to the exact date of arrival, you must cancel and try to re-book the reservation, OPRD will retain the first night's use fee/deposit.
- Reservations may be made up to 9 months in advance of the date of arrival. Date changes to any reservation cannot be made until 8 months in advance of the arrival date.

All fees and policies are subject to change.
